2. Summary of the discipline

The course "European Studies" is aimed at familiarizing students with the evolution, foundations of the legislation and institutional organization of the European Union, as well as the history and prospects of the role of the European Union as a global actor. As the course is being implemented,

in particular, within the framework of the Jean Monnet INTEGTRADE module with the support of the European Union, special attention will be paid to the role of free trade as a basis for integration of the EU states and strengthening the role of the EU in the international arena. The course also aims to familiarize students with the growing role of non-trade objectives, such as climate change, sustainable development, rule of law and anti-corruption, in EU trade policy and foreign trade agreements between the EU and third countries. This topic is particularly relevant for Ukraine in the context of the implementation of the Association Agreement, including the Deep and Comprehensive Free Trade Area (DCFTA), and the prospect of membership in the European Union, which will require Ukraine's full integration into the EU Internal Market. The program is accompanied by the development of students' skills in working with scientific and political literature, analytical texts and relevant legislation, as well as communicating complex political and legal phenomena in simple language and with the help of graphic means (creating infographics). As a result of the course, students will develop a detailed understanding of the current state of EU development, the state and prospects of EU-Ukraine relations, as well as trade liberalization as the basis for the functioning of the Union and the evolution of its role in the international arena.

3. The purpose of studying the discipline

The purpose of the course consists of four key, equivalent components:

- **1.** To familiarize students with the theoretical foundations of the discipline "European Studies" and the current state of development of the European Union and its global role.
- **2.** To develop students' understanding of the role of trade in the development of the European Union and its global role, as well as the causes and consequences of the growth of non-trade objectives in EU trade policy.
- **3.** To develop students' knowledge of the Association Agreement and the DCFTA as the basis for EU-Ukraine cooperation and Ukraine's European integration.
- **4.** To improve students' skills related to communication of Ukraine's European integration, in particular, through the use of graphic materials.

As a result of the course, the student will know:

- **Key theories of European integration** (functionalism and neo-functionalism, multi-level governance) and **ways to apply general theories of international relations to the phenomenon of European integration** (realism, liberal intergovernmental approach, constructivism).
- The main stages of the development of European integration from the creation of the European Coal and Steel Community to current events in light of the EU's support for Ukraine in the war unleashed by the Russian Federation.

- The principles underlying the **EU's Common Market** and the role trade plays in the functioning of the European Union and its non-trade goals in the areas of sustainable development, climate change, human rights, rule of law, etc.
- How the EU-Ukraine Association Agreement functions and on what basis free trade between Ukraine and the European Union is realized.

Will be able to:

- Use the EULEX database of EU legislation, relevant academic literature and analysis.
- Understand and explain the links between different policy areas, in particular, trade policy and policies in the field of sustainable development, anti-corruption, rule of law
- **Understand the content of the Association Agreement** and describe the main obligations of Ukraine to approximate its legislation to the EU acquis in various areas (trade in goods and services, public procurement, climate change)
- Communicate information about European integration, in particular, using graphic methods.
