TRADE IN INDUSTRIAL PRODUCTS

LIBERALIZATION OF TRADE IN INDUSTRIAL PRODUCTS, INCLUDING MACHINERY AND EQUIPMENT. THE APPROXIMATION OF UKRAINIAN LEGISLATION TO EU NORMS AND STANDARDS IN TRADE-RELATED AREAS WILL HELP TO IMPROVE THE QUALITY AND COMPETITIVENESS OF UKRAINIAN INDUSTRIAL PRODUCTS IN THE EUROPEAN MARKET.



CANCELLATION OF TARIFFS AND DUTIES



GRADUAL CANCELLATION OF DUTIES ON MANY PRODUCT GROUPS, INCLUDING AGRICULTURAL PRODUCTS. DUE TO THE FACT THAT UKRAINE RECEIVED A SIGNIFICANT QUOTA FOR THE EXPORT OF CERTAIN GOODS WITHOUT DUTIES, UKRAINIAN PRODUCERS CAN INCREASE THEIR PRICE COMPETITIVENESS IN THE EUROPEAN MARKET.

INTEGRATION INTO THE EU SINGLE MARKET

THE DCFTA PRIORITY IMPLEMENTATION ACTION PLAN FOR 2023-2024, ESTABLISHED IN 2020, CONTAINS A NUMBER OF MEASURES TO ACCELERATE AND MONITOR THE FULL IMPLEMENTATION OF THE DCFTA, PROVIDING UKRAINE WITH ADDITIONAL ACCESS TO THE EU SINGLE MARKET AND DEEPENING INTEGRATION WITH THE EU IN THE ENERGY, TRANSPORT AND AGRICULTURAL SECTORS



STRENGTHENING CROSS-BORDER COOPERATION



DUE TO THE COMMON BORDER WITH FOUR EU MEMBER STATES: POLAND, SLOVAKIA, HUNGARY, AND ROMANIA, CROSS-BORDER COOPERATION BETWEEN UKRAINE AND THE EU WILL BE DEEPENED IN SUCH AREAS AS TRANSPORT, INFRASTRUCTURE, ENERGY, ENVIRONMENT, AND TOURISM

INVOLVEMENT IN THE EU DIGITAL MARKET
